Hi Kevin,

Thanks for following up. Just finished reading the report and have several comments below. Let me know if you have time to discuss later this morning around 11:15a.

1) Parking Lot Analysis

Both project alternative options should include a parking turnover study that documents that current use demand of the existing parking lot to determine what impact the proposed changes would have on the use of the lot. It would be OK to document parking activity not related to the current use demand. If no current use and lot is fenced off then just note that in the report.

2) LOS Analysis

Looks OK, no suggested changes there.

3) Ingress/Egress Analysis

Include a discussion that evaluate entry and exit into the lot from the two FCB lots. Discuss any operations changes for signage or striping such as KEEP CLEAR pavement messages or DO NOT BLOCK INTERSECTION signage. Look at Queue from SB approach of FCB & Chess to make a decision.

4) STOP Sign Controls at Driveway onto FCB

Recommend adding STOP signs, limit line, and STOP legend on pavement at driveway approach(es) that will be used for egress onto FCB from parking lot.
