A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF FOSTER CITY APPROVING THE AFTER SCHOOL ACTIVITY (ASA) BUS PROGRAM FUNDING AGREEMENT BETWEEN THE CITY OF FOSTER CITY AND THE SAN MATEO UNION HIGH SCHOOL DISTRICT FOR A CONTRIBUTION IN THE AMOUNT OF \$21,667.50 TO THE ASA BUS PROGRAM FOR THE 2022-2023 SCHOOL YEAR, AUTHORIZING THE CITY MANAGER TO EXECUTE THE FUNDING AGREEMENT, AND AUTHORIZING AN APPROPRIATION IN AN AMOUNT NOT-TO-EXCEED \$21,667.50 TO THE COMMUNITY BENEFITS PROGRAM FUND, ACCOUNT NO. 005-0110-413-4251, TO FUND THE CONTRIBUTION

WHEREAS, the City of Foster City (City) wants to assist in providing safe transportation for Foster City students who participate in after school activities at San Mateo High School; and

WHEREAS, the San Mateo Union High School District (District) provides an After School Activity (ASA) Bus Program to Foster City students picking up at San Mateo High School at 6:30 p.m. and drops students off at nine (9) stops throughout Foster City; and

WHEREAS, the District has requested that the City contribute an amount not-to-exceed \$21,667.50 for the 2023-2024 School Year; and

WHEREAS, funding for the ASA Bus Program is traditionally available in the City Manager Department Community Benefits Program Fund; and

WHEREAS, a budget appropriation is required since the funding request from the District was received after the City's Final Budget for FY 2023-2024 was adopted; and

WHEREAS, the City wishes to make a one-time payment to the District to provide funding in support this ASA Bus Program because it provides a valuable service to children and parents in Foster City and provides an additional broader benefit to the residents of Foster City because the ASA Bus Program reduces individual automobile trips currently required to transport children who will instead use the after school program bus.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Foster City does hereby approve the After School Activity (ASA) Bus Program Funding Agreement for the 2023-2024 School Year between the City of Foster City and the San Mateo Union High School District for a one-time contribution payment of \$21,667.50, and authorize an appropriation in the amount not-to-exceed \$21,667.50 to the Community Benefits Program Fund, Account No. 005-0110-413-4251, to fund the contribution.

BE IT FURTHER RESOLVED that the City Council does hereby authorize the City Manager to execute the ASA Bus Program Funding Agreement in the form attached hereto, with minor revisions that may be approved by the City Manager and the City Attorney, and to execute any other necessary documents to effectuate the terms of the Agreement.
