# 9. STUDY SESSION

1. OBJECTIVE DESIGN AND DEVELOPMENT STANDARDS FOR MULTI-FAMILY RESIDENTIAL HOUSING AND MIXED-USE DEVELOPMENT APPLICATIONS AND RELATED AMENDMENTS TO VARIOUS CHAPTERS OF TITLE 17, ZONING, OF THE FOSTER CITY MUNICIPAL CODE, INCLUDING BUT NOT LIMITED TO 17.04 DEFINITIONS; 17.14 R-2 TWO FAMILY RESIDENCE DISTRICT; 17.16 R-T TOWNHOUSE RESIDENCE DISTRICT; 17.18 R-3 MEDIUM DENSITY MULTIPLE-FAMILY RESIDENCE DISTRICT; 17.20 R-4 HIGH DENSITY MULTIPLE-FAMILY RESIDENCE DISTRICT; 17.26, C-2 GENERAL BUSINESS DISTRICT; 17.38 C-M COMMERCIAL MIX DISTRICT; 17.36 PD PLANNED DEVELOPMENT COMBINING DISTRICT; 17.58 ARCHITECTURAL CONTROL AND SUPERVISION; AND 17.62 OFF-STREET PARKING REGULATIONS.

## Planning Commission comments:

- Chair Jagtiani requested that the bicycle parking requirement be expressed as 1
  parking space per 10 dwelling units instead of 0.1 spaces per dwelling unit.
- Commissioner Haddad inquired about the density.
  - Consultant Planner Carmichael responded that the proposal does not change any of the allowed densities, it just shows them in units per acre instead of the current method of square feet of lot area required per unit.
  - Deputy City Attorney Bazzano added that each development project will need to meet these requirements, any other City or EMID requirements, and also be analyzed pursuant to CEQA.
- Chair Jagtiani asked if the definition of height for sloped roofs would stay the same.
  - o Consultant Planner Carmichael responded yes.
- Commissioner Bronitsky stated he felt that there should not be a limit on synthetic turf.
   Regarding a public comment suggesting design standards for each neighborhood, that is just not realistic. Regarding guest parking, the demand varies depending on the day.

#### Public comments:

- Evan Adams asked if there was a letter from HCD that's not on the Foster City website.
  The synthetic turf area recommended seems small. Multi-metering is a good idea. The
  standards should address individual styles in each neighborhood. Bicycle parking
  should address charging requirements.
  - Director Mangalam stated that staff is not aware of any HCD letter regarding objective design standards. HCD letters regarding the Housing Element have been posted on the website.
  - o Consultant Planner Carmichael stated that the objective standards need to accommodate the maximum densities allowed by the general plan.

After discussion, Commissioners confirmed the consensus is to have no maximum limit on the amount of synthetic turf.

## 11. STATEMENTS AND REQUESTS FROM THE COMMISSIONERS

- 1. Commissioner Bronitsky shared that there will be a food distribution event at the Second Harvest Food Bank on Friday, October 20th at 8:30 AM. This event is open to the local community, not just Foster City residents, and is aimed at addressing food insecurity. It takes place on the first and third Fridays of each month, providing food items such as chicken, vegetables, and staples to those in need. He also mentioned an upcoming opportunity to speak at a training for Planning Commissioners on October 30th, expressed excitement about the opportunity.
- 2. Commissioner Pedro mentioned looking forward to seeing Commissioner Bronitsky on October 30th for his presentation. He discussed his attendance at a citizens' Sustainability Advisory Committee meeting, where there was a focus on electrification. He later toured a decarbonized home in San Mateo. He recommended that homeowners, property managers, and housing providers consider replacing their water heaters and furnaces with electric heat pumps in anticipation of upcoming mandates, as it might be more cost-effective to do so now rather than later.
- 3. Commissioner Haddad was thankful for an excellent report presented by the City staff and consultant.
- 4. Chair Jagtiani expressed gratitude for a great report and promoted the upcoming Baybasi event starting tomorrow, October 20th. He recommended that everyone attend, emphasizing the presence of numerous food stalls, enjoyable music, and an improved location in Leo J. Ryan Park, making it even better than previous years.
