A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF FOSTER CITY APPROPRIATING \$250,893 FROM THE VEHICLE REPLACEMENT FUND TO ACCOUNT NO. 501-0560-431-4384 AND AUTHORIZING THE SOLE SOURCE PURCHASE OF A NEW CATCH BASIN CLEANER TRUCK FROM STETCO GROUP, LLC IN THE AMOUNT OF \$250,892.82 AND AUTHORIZE THE CITY MANAGER TO APPROVE THE PURCHASE ORDER

WHEREAS, the existing Catch Basin Cleaner Truck is twenty (20) years old and in need of replacement; and

WHEREAS, this Truck fitted with the specialized piece of equipment is important for cleaning out catch basins throughout Foster City and is a vital part of the emergency equipment during storm events; and

WHEREAS, on October 18, 2021, the City Council adopted Resolution No. 2021-153 authorizing the purchase of the Catch Basin Cleaner Truck for a total amount of \$248,771.01 in FY 2021-2022 from Ford and National Auto Fleet Group to replace the existing Truck; and

WHEREAS, National Auto Fleet Group has been unable to fulfill and has therefore cancelled the order; and

WHEREAS, Foster City Municipal Code section 3.04.110 provides that the bidding requirements in the City's Purchasing Policy may be dispensed with for commodities that can be obtained from only one vendor (i.e., a sole source purchase); and

WHEREAS, Stetco Group is the sole provider of the Catch Basin Cleaner and also has the ability to obtain the Ford F-750 chassis to build the vehicle; and

WHEREAS, funding is available in the Vehicle Replacement Fund 501 for this purchase.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Foster City does hereby:

1. Approve the appropriation of \$250,893 from Vehicle Replacement Fund 501 to Account No. 501-0560-431-4384; and
2. Approve the sole source purchase of a 2024 Ford F-750 Diesel Regular Cab Base (F7D) Truck and Stetco 950 Unit Catch Basin Cleaner equipment (Catch Basin Cleaner) for a total cost of \$250,892.82 from Stetco Group, LLC. and authorize City Manager to approve the Purchase Order.
