A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF FOSTER CITY AUTHORIZING AWARD OF VENDOR AGREEMENT TO SCA (SWEEPING CORP OF AMERICA) OF CA, LLC, IN AN ANNUAL AMOUNT NOT TO EXCEED \$131,000 FOR STREET SWEEPING SERVICES FROM JUNE 1, 2023 THROUGH DECEMBER 31. 2025, WITH OPTIONAL EXTENSIONS THROUGH DECEMBER 31, 2028; AUTHORIZING THE MAYOR TO EXECUTE THE AGREEMENT; AUTHORIZING THE CITY MANAGER TO EXTEND THE AGREEMENT WITH ASSOCIATED CONTRACTUALLY-DEFINED INCREASES: AND FINDING APPROVAL AGREEMENT CATEGORICALLY EXEMPT FROM REVIEW UNDER THE CALIFORNIA ENVIRONMENTAL QUALITY ACT (CEQA)

## CITY OF FOSTER CITY

WHEREAS, A Request for Proposal (RFP) for Street Sweeping Maintenance was authorized by the Council on February 21, 2023 and distributed and proposals were received from two (2) companies; and

WHEREAS, the proposals were evaluated on the basis of the annual proposal amount for routine street sweeping maintenance costs and other estimated maintenance items; and

WHEREAS, SCA (Sweeping Corp of America) of CA, LLC's proposal was the lower of the two (2) proposals received; and

WHEREAS, the agreement will be for an initial contract period of thirty-one (31) months from June 1, 2023 through December 31, 2025, with the option to extend the contract for three subsequent twelve (12) month contract periods; and

WHEREAS, City has previous satisfactory experience with the services of SCA (Sweeping Corp of America) of CA, LLC.

NOW, THEREFORE, BE IT RESOLVED that the City Council of Foster City does hereby:

- 1. Find that this action is categorically exempt from the requirements of the California Environmental Quality Act ("CEQA") pursuant to Title 14 California Code of Regulations § 15301 (c) as a Class 1 categorical exemption (Existing Facilities) as it involves the maintenance of existing streets.
- 2. Award a Vendor Agreement to SCA (Sweeping Corp of America) of CA, LLC, in an annual not to exceed amount of \$126,000 for routine street sweeping services and up to \$5,000 for additional street sweeping services

from June 1, 2023 through December 31, 2025 and authorizes the Mayor to execute the Agreement.

3. Authorizes the City Manager to extend the Agreement with SCA (Sweeping Corp of America) of CA, LLC, and authorize associated contractually-defined increases based on the Consumer Price Index on a calendar year to calendar year basis, from January 1, 2026, through December 31, 2028, upon demonstration of satisfactory performance, as may be determined by the City Manager.
